Basic Policy for Respecting Diversity of Sexual Orientation and Gender Identity (SOGI) at Ehime University

In accordance with our principle of becoming a university that leads our region and connects it to the world with striking originality, we formulated the Ehime University Diversity Promotion Statement. In the statement, Ehime University declares that it will further promote diversity by providing a place where mutual respect and collaboration, regardless of differences in sexual orientation and gender identity, can take place.

Ehime University respects diverse sexual orientations and gender identities (SOGI) and aims to develop an understanding and environment for inclusion based on the following policies.

- We will create an environment that prevents prejudice and discrimination against diverse sexual orientation and gender identity (SOGI) in education, study, research, employment, and other settings.
- 2. We will ensure the protection of personal information related to sexuality.
- Training and lectures will be held with the aim of promoting understanding of and respect for diverse sexual orientations and gender identities (SOGI) and resolving difficulties by those concerned.
- 4. For concrete actions, we respect the wishes of the person with concerns and aim to reach a consensus.

1. Use of Alias Names

- (2) When participating in off-campus practical training (educational training, etc.), when reasonable accommodations are required in terms of restrooms, locker rooms, and clothing at the training site.
- (3) When reasonable accommodations are required for the use of names in class.
